TERMS AND CONDITIONS OF ENROLMENT:

- 1- Fees are payable by the 5th of every month, irrespective of whether classes are attended or not.
- 2- Fees are payable by eft or at the dojo in cash (receipt will be issued). No cheques accepted.
- 3- Fees are payable from 1st January to 31st December, no exceptions. Fees are calculated on a 4 week month. Where there are 5 weeks in a month, this will make up for the rare occasion that classes are cancelled and for the December holidays.
- 4- Notice to leave may not be given after 31st October each year. The dojo will be closed for some of the December/January school holidays. You are still required to pay in full for those months whether classes are attended or not.
- 5- Fees increase annually at the beginning of each year.
- 6- Fees not paid will be sent to a debt collector and you will be liable for any costs incurred
- 7- Affiliation fees are payable and renewable annually at the beginning of the year for existing students and upon joining for new students. This may include affiliation to SA Jka, KASA (WKF) and or any other bodies to which we may affiliate from time to time. Affiliations are annually renewable fees and should not be confused with dojo membership.
- 8- Karateka are responsible for the stamping of their attendance cards which is essential for grading purposes
- 9- Please note that "juniors" refers to students under the age of 18 and "seniors" over the age of 18
- 10- The member and/or guardian of the member hereby indemnifies the Club and/or its instructors against any claims that may occur as a result of any injuries sustained or loss of property, that may occur to the member or his property, during the course of his training, as well as during outside training camps and tournaments

Termination of contract

- 1- One (1) calendar month notice is required to terminate lessons.
- 2- I acknowledge that fees will be *due and payable for the cancellation month*.
- 3- On receipt of written notice (must be dated) the karate club will provide the parent with written confirmation within seven (7) days of receipt thereof, to be kept as proof of notice
- 4- In the event of any dispute arising relating to receipt of written notice by the club, the parent shall bear the onus of proving that the karate club received such notice by presenting the written receipt of notice
- 5- No telephonic or verbal notice will be accepted
- 6- This contract and membership commences upon signature of this agreement and will be ongoing until termination of membership is served, irrespective of the expiration of an affiliated year.
- 7- Grading, tournaments and gasshuku's (training camps) are an additional cost and are not compulsory.
